You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you selected arrangements such as direct cremation or immediate burial, you do not have to pay for embalming you did not approve.

Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any pre-need agreement, in the possession of the funeral establishment, that has been signed and paid for, in full or in part, by or on behalf of the decedent.

Terms of payment

Payment is due in full prior to services being rendered. We accept Visa, Discover and MasterCard. Payment plans are also available through Affirm.

Includes the basic services of a funeral director and staff, the collection of the decedent from a hospital or coroner's office, sheltering the decedent in refrigeration for up to 5 days including the day the decedent was brought into our care, an alternative cremation container, transport to crematory, crematory fee, plastic utility urn, and the packaging and mailing of cremated alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are fiberboard.
